

**AMENDMENT TO

Paragraph 5 of said Restrictions for Fox Run Estates is hereby deleted and amended to read:

- 5. Fences shall be allowed to be erected in Fox Run Estates provided they are completed in a good and workmanlike manner, and shall be maintained so as not to become unsightly or tend to offend the normal sensibilities of other residents or owners of property in Fox Run Estates.

All remaining Restrictions of Fox Run Estates shall remain in full force and effect.

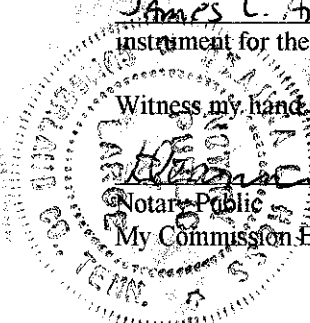
